

ArtPlace America Selects 21 Finalists for \$18 Million Grant Program

PolicyLink Selected as National Research and Documentation Partner

May 4, 2015--ArtPlace America (ArtPlace) today announced 21 finalist organizations that have been selected from a pool of 261 applications to participate in its new Community Development Investments program. Six organizations will be chosen from the finalists in August 2015 to receive funds.

The Community Development Investments (CDI) is a one-time program that will support place-based organizations with a primary mission of community planning and development to incorporate arts and cultural strategies into their work. The program will provide each organization up to \$3 million in grant funding over three years, as well as access to national creative placemaking experts, a team that will look at the deployment of debt capital, and a team to advise on federal grant opportunities.

The CDI program is designed as a learning opportunity for both the grantee organizations and for the broader fields of arts and community development. ArtPlace has selected the national research and action institute PolicyLink to serve as its Research and Documentation partner for the duration of the three-year grant program. PolicyLink was identified through a national competition that drew fourteen applications from research teams.

"Too often, arts and culture has been missing from comprehensive community development conversations. ArtPlace has been a leader among those working to change this," said Rip Rapson, President and CEO of The Kresge Foundation and chair of ArtPlace's Funders Council. "Through this newest grant program, ArtPlace will help six place-based organizations incorporate creative placemaking strategies into their standard operating procedures."

"The 261 applications we received are evidence of the growing interest in recognizing that arts and culture is among the core sectors of any thriving community," said ArtPlace Executive Director Jamie Bennett. "We are thrilled that PolicyLink, with their deep experience working both in communities and with national policy makers, will partner in embedding what we learn through this program in the broader place-based strategy conversation across the United States."

"PolicyLink is dedicated to Lifting Up What Works to drive national research, policy, and action," said Angela Glover Blackwell, founder and CEO of PolicyLink. "In places all across this country, arts and culture are essential to the development and implementation of strategies to secure sustainable communities of opportunity and prosperity. We look forward to partnering with ArtPlace to capture those lessons and share them broadly."

The finalist organizations for the CDI program represent a wide range of contexts and focuses, from community development corporations to public health organizations to universities working on challenges from housing development to food systems to commercial corridors. Finalists were selected from six defined geographic regions across the country through a review process that included experts in the fields of community development and creative placemaking.

One organization from each of the six regions will be chosen to participate in the program, which will begin in September 2015. The 21 finalist organizations and regions include:
